DNR MEETING IN SPRINGFIELD - Follow up

City will submit by August 5, 2016 a short term and long term plan on what they will be doing to keep the wwtf in compliance with their Missouri State Operating Permit, along with an update on what has been done and will be done in the collection system to help with Inflow and Infiltration during rain events. This plan will be submitted for review to the Department's Southwest Regional Office in Springfield.

WATER REPORT - Lawson Laboratories

Water samples were taken and submitted / analyzed as required by DNR. The results indicated that all three wells are satisfactory. Test results are available upon request.

UV SYSTEM REPORT - Duane Ottmar

Resubmit plan to DNR for UV project. This plan must be in the hands of the DNR ASAP to ensure funding. It will be a 50/50 split on the finances. Also, a short and long range plan is needed for DNR to insure compliance with our permit. A meeting in tentative and will include this staff and members of the DNR. This meeting will be before the end of this month.

OUT OF STATE VEHICLE SALES TAX: DEADLINE EXTENDED

Governor Jay Nixon signed House Bill 2140 that provides a two-year extension for jurisdictions that do not have a use tax to hold a vote on the local sales tax for motor vehicles, trailers, boats and outboard motors purchased from private seller or out-of-state dealers and then titled in Missouri



NEW FAIR LABOR STANDARDS ACT OVERTIME RULE

New rule effective December 1, 2016. It will raise the salary threshold for exemption from overtime from \$455 a week (\$23,660) to \$913 per week (\$47476). The new rule will likely affect many city department heads and supervisors.

GIS KICKOFF MEETING

The meeting will be June 29th at 1:00 p.m. for the kick off of the GIS system for our city. Mr. John Gilmore, GIS/IT Professional, will be conducting the meeting. Equipment will be installed over the next few weeks and proper training will begin next month. At this first meeting we will load our utility pole information into the system.
