Overview

The Missouri Enhanced Enterprise Zone (EEZ) program gives local governments authority to partner with the state in providing financial incentives for qualifying projects. Seymour offers one of Missouri's most-aggressive EEZ programs, with abatement up to 90% upon local real property taxes above the current baseline. This enables Seymour to promote a wide variety of business projects.

Projects Eligible For Participation

Qualifying projects must meet defined standards for participation in the EEZ program.

Eligibility criteria includes:

- Minimum investment and employment criteria, in accordance with state and local guidelines, must be met in order for projects to qualify for the program. The minimum investment and employment criteria are two new employees and \$100,000 new investment.
- Projects must be for business and industry types specifically authorized by the state of Missouri and local ordinance to be eligible for the EEZ program.
 Businesses must fall within the North American Industry Classification System (NAICS) industry codes approved by the Seymour Enhanced Enterprise Zone board of directors.

Local Real Property Tax Abatement

Eligibility Criteria

The Enhanced Enterprise Zone program is a discretionary program offering local real property-tax abatement qualifying business enterprises. Tax credits may be provided each year for up to 10 tax years after the project commences operations (subject to annual recertification).

Eligible Business Types

The NAICS codes approved by the board are quite broad, and incentives therefore are available for a wide array of projects. Industry codes eligible for the Seymour EEZ program are:

Certain types of businesses and industry clusters are not available for participation in EEZ programs. They include:

- Gambling establishments (NAICS group 7132),
- Retail trade (NAICS sectors 44 & 45),
- Educational services (NAICS sector 61),
- Religious organizations (NAICS group 8131),
- Public administrators (NAICS sector 92),
- Ethyl Alcohol Manufacturing (NAICS code 325193), and
- Petroleum Refineries (NAICS code 324110).


Food and drinking places (NAICS subsector 722) are prohibited by statute from receiving the state tax credits.

The minimum amount of local tax abatement on new improvements is 50%. However, bonus points may be awarded up to a cap of 90%, based upon the criteria listed below:
